1 Briefly describe the organization's mission: SINCE 1987, DELAWARE COMMUNITY REINVESTMENT ACTION COUNCIL (DCRAC) HAS SERVED THE COMMUNITY AS A STRONG CONSUMER ADVOCATE, EFFECTIVE EDUCATOR OF CONSUMER FINANCE, FORECLOSURE PREVENTION PROFESSIONAL, TITLE & TAX ATTORNEYS, AND AS A BANKER. DCRAC'S MISSION IS TO ENSURE EQUITABLE

LOW INCOME TAX CLINIC: AS PART OF THE INTERNAL REVENUE SERVICE RESTRUCTURING AND REFORM ACT OF 1998 (RRA 98), CONGRESS ENACTED IRS SUBSECTION 7526 TO AUTHORIZE FUNDING FOR THE LOW INCOME TAX CLINIC GRANT PROGRAM. THE PROGRAM PROTECTS TAXPAYERS' RIGHTS BY PROVIDING ACCESS TO REPRESENTATION FOR LOW-INCOME TAXPAYERS, SO THAT ACHIEVING A CORRECT OUTCOME IN AN IRS DISPUTE DOES NOT DEPEND ON THE TAXPAYER'S ABILITY TO PAY FOR REPRESENTATION. MANY LOW-INCOME TAXPAYERS ARE ALSO INDIVIDUALS FOR WHOM ENGLISH IS A SECOND LANGUAGE (ESL TAXPAYERS). CONSEQUENTLY, CONGRESS AUTHORIZED FUNDING FOR ORGANIZATIONS TO PROVIDE OUTREACH AND EDUCATION ABOUT TAXPAYER RIGHTS AND RESPONSIBILITIES TO ESL TAXPAYERS IN ADDITION TO REPRESENTING LOW-INCOME TAXPAYERS IN CONTROVERSIES WITH THE IRS. REPRESENTATION, EDUCATION, AND ADVOCACY
